Content description:

1846 to 1915: Miscellaneous Index in A-Z order by first letter of Partnership name, then in order of book, and then page in record book. Example: J.J. Peebles .. 19 July 1864 .. business to be transacted for 3 years ... \$20,000 in partnership stock ... wholesale & Retail Grocery (book 1 p. 218)

1846 to 1934: Sundries Index in A-Z order by first letter of Partnership surname, then in order of book, and then page in record book. Document type "Partnership" indicated.

Partnership Alpha Index: Microfilms labeled "Partnership Index A-B,... T-Z, 1894-1988" indexes all the names of the partnership documents on the "General" and "Limited" microfiche and microfilms. The index is of cards sequenced alphabetically by partnership name, sometimes with partner names and addresses. Those that begin with a number are at the end of the list of the first letter of the number spelled out, i.e., "623" would be at end of "S" for Six. Example:

General                      Hannaford & Sons, Samuel                      7/29/1897

Partners Alpha Index: Microfilms of cards that index all the names of the partners documents on the "General" and "Limited" microfiche and microfilms. The card index is sequenced alphabetically by partner surname, first name, then document date. Card includes partner names and addresses. "Partners Index A-B,... G-H, 1894-1988" are on 5 microfilms. For "I to Z" ask the staff to search for the name.
